Only Vertical Turbine Pump Installers and Deep Excavation & Shoring Contractors who have submitted the required pre-qualification information and received qualified status by the City prior to bidding may be named in the submitted Bid. Statements for Qualification shall be presented to the City no later than 2:00 p.m. local time on Friday, December 04, 2009. Notification of qualification status will be made available by the City no later than 5:00 p.m. local time on Tuesday, December 08, 2009. The minimum qualifications and submittal requirements are described in the Special Provisions of the Invitation to Bid Packet.

A mandatory Pre-Bid Conference will be held at 10:00 AM local time, on Monday, November 30, 2009, at 12475 SW Bull Mountain Road, Tigard, OR 97224

Work under this ITB's resulting contract will be funded, in part or in its entirety, with federal funds from the American Recovery and Reinvestment Act through the Safe Drinking Water Revolving Loan Fund.

PERMITS

The City of Tigard shall be billed directly for any and all agency costs associated with permits required in accordance with the work covered by any contract resulting from this Invitation to Bid. Any reference to Contractor being required to pay an agency cost for a permit shall be changed by this Addendum to instead reference the City (or Owner) paying for the agency cost of the permit. Bidders should not include estimated agency permit cost in their bid submittals based on this decision by the City. Contract shall be responsible for submitting and obtaining the permits including any ancillary administrative costs associated with the permit acquisition.
