



Code Compliance Request - Instructions

City of Tigard Code Compliance

The City of Tigard provides online services for citizens to submit a code compliance request. To report a code violation and submit a code compliance request, you will need to provide the following:

- The type of code violation being reported (see table below)
- The address or parcel number of the property where the observed violation exists
- Contact information for the complainant
- A description of the observed violation, including the location on the property.
- Supporting documentation such as photos, maps, letters, illustrations, etc. may be helpful and is optional.

Please note that all information entered into the online code compliance system becomes public record, including your contact information.

Selecting the Record Type

Before proceeding with your code compliance request, you will need to determine which record type to select based upon the type of infraction observed. Please use the table below to determine the record type.

Code Compliance Request - Instructions

Step 1: Location

Each code compliance request must contain either an **address** or a **parcel number**. If you do not know the address, or if the location is a vacant lot, please use the City’s online mapping service, [Tigard Maps](#), to find the address or parcel number. In Tigard Maps, you can search nearby addresses or street intersections to find the site information.

Address: Enter the address in the fields provided and click on the Search button to display results. There may be only one address displayed, or multiple addresses with different suite or unit numbers.

- **Street Name Example:** For numbered streets, you must include the entire name as 100th, 72nd, 121st, etc.

Parcel: If you are entering a parcel number, please be sure to enter it in the format as it appears in Tigard Maps.

- **Parcel Number Example:** 2S102DA00401

Enter the street number, select the direction, enter the street name, select street type and enter a unit number if applicable, then click on the Search button.

In the example below, we have entered the city's address. Once the address is returned, the parcel number will be automatically populated (see Parcel screen below).

Step 3: Observed Infraction

In this section you are required to enter information about the type of infraction(s) you observed.

- For each observed infraction, click on the Add a Row button.
- Select an Infraction Type from the dropdown list. If you do not see the appropriate item in the list, you may have selected the wrong case record type in the beginning. If so, you can click on the back arrow to return to the Select a Case Type screen. Please view the table on Pages 1-2 above to determine the correct record and infraction type.
- Provide a detailed description about the infraction. Please include information about the conditions of the site that are not in compliance and where on the site these conditions exist (front yard, side yard, driveway, etc.).




The File Upload window will be displayed. Click on Add to browse and select a file on your computer.
