- Use a permit when the permit holder is no longer entitled to the permit.
- Use, or allow the use of, a permit in a manner inconsistent with the terms and limitations of the permit or TMC 10.30.070.

I agree to use any parking permit(s) issued to me only on the specific vehicle assigned by the City of Tigard Police Department and only for the purpose for which it was issued. Any parking permit(s) remain the property of the City of Tigard and may be revoked if improper use is demonstrated. I agree to surrender any permit rights to the City if I change residences.

I agree to allow the use of guest parking permit(s) by visitors only and understand that residents may not use a guest parking permit at any time. Restrictions on the maximum days used per vehicle may be part of the Residential Parking Plan.

Violations may result in the immediate revocation of a resident or guest parking permit and, upon conviction, be punishable by a fine set by resolution of the City Council.

Permits are valid from July 1st to June 30th and must be renewed each year.

Residential Parking Permit Application

How to Apply:

Applications can be completed online using **Citizen Connect** or through a paper application. The online application is mobile phone friendly and the required documents can be uploaded from your phone's camera

Visit www.Tigard-OR.gov/ParkingPermits or www.ToCite.net/TigardOR/Portal to apply.

To purchase permits, residents must:

1. Complete an application
2. Provide proof of residency within the residential parking zone
3. Provide their vehicle registration (the permit will be linked to the license plate)
4. Pay the permit fee

Accepted forms of proof of residency are:

- Deed
- A utility bill dated within the last 30 days (Water, power, natural gas, or internet/land-line phone)
- Lease or Rental agreement
- Oregon Driver License of Identification IF it shows the current address
- Voter registration card

Proof of vehicle ownership includes:

- Current Oregon Vehicle Registration Card showing owner or lessee name
- Vehicle title
- Oregon DMV Notice of Transaction with the stamped date/time received by the DMV

Work / Employer Vehicles:

Employers sometimes provide take home vehicles that may require on-street parking. A permanent resident parking permit may be assigned to a work vehicle if a resident provides proof of residency, a copy of the vehicle registration (showing company ownership), and proof of employment.

Proof of employment includes:

- Documentation on company letterhead
- Work identification showing the resident's name and company name
- A business card showing the resident's name and company name.

Permit Cost:

The cost for Fiscal Year 2020-2021 is **\$5.00** for the first two Resident Owned Vehicle Permits and **\$5.00** for each additional vehicle thereafter.

Payment:

Payment can be made by cash, check, or credit/debit card. Payment can be dropped off or mailed to the
